Summary: April 1, 2023 is the beginning of Year 5 of the Plumber Transition Plan. Please continue to dual stream Current Level 4 (CL4) alongside Harmonized Level 4 (HL4) as needed to accommodate apprentices who have completed Current Level 3 (CL3).
 Apprentices who have completed Current Level 2 (CL2) will need to contact their [Apprenticeship Advisors](#) *before* registering for their next courses.
 In addition, please continue to dual stream Current Level 4 (CL4) alongside Harmonized Level 4 (HL4).



Background: On March 2, 2018 ITA Program Standards issued [OPSN 2018 001.1](#), which detailed the changes to the Plumber Program as a result of the Harmonization Initiative and announced the implementation of a revised Program Outline, effective April 1, 2019. Further to this, on September 20, 2018, ITA issued a [Program Update](#) announcing the [Transition Plan](#).

Dual Streaming: For information about **how to determine which program to register an apprentice in**, please refer to the [Registration Guide for Training Providers](#), or contact assessmentscoordinator@skilledtradesbc.ca.

Where dual streaming is indicated in a transition plan, **apprentices should remain in their program.**

- Apprentices who have completed CL3 cannot transition into the harmonized program. They must take CL4. **(i.e., CL3 take CL4)** Please do not allow apprentices in the current program to register in HL4, as this will result in serious gaps in their training.
- Apprentices with Harmonized Level 3 (HL3) must take HL4. **(i.e., HL3 take HL4)** Apprentices who have completed the previous level in the HL program must take the next level in the HL program. Allowing apprentices to register into the CL program will result in serious gaps in their training.



HL2 apprentice must take HL3. **Do not register this apprentice for CL3.**
CL2 apprentice must take CL3. **Do not register this apprentice for HL3.**
