#### **Rationale:**

- Industry, through the BC Crane Safety Assessment Review Panel (ARP), has requested this change to provide a smoother pathway to certification for apprentices and trade qualifiers (challengers).
  - This change will allow:
    - an apprentice to attempt the practical assessment at the end of their final level of technical training if they choose to. They will not have to wait for their SLE result prior to booking an attempt.
    - a trade qualifier (challenger) to attempt the practical assessment and certification exam in the order they determine.
      - Note: for Mobile Crane Operator and Tower Crane Operator, a trade qualifier (challenger) must still successfully complete all SLEs prior to attempting the practical assessment.
  - By allowing apprentices and trade qualifiers (challengers) the flexibility to attempt the practical assessment more in accordance with their schedule and needs, the expected outcome of this change is higher certification rates in crane trades.
  - This change does not decrease requirements for certification. To achieve certification, all completion requirements remain in effect and unchanged. The change is only to the order in which the practical assessment completion requirement may be attempted.
  - Practical assessment prerequisites are not a requirement set in the Red Seal Occupational Standards (RSOS) for Mobile Crane Operator or Tower Crane Operator. Some jurisdictions do not require a practical assessment as part of Red Seal completion requirements. Refer to the <u>Ellis</u> <u>Chart</u> for jurisdictional details on the delivery of Red Seal programs.
