ckground: On June 26, 2020, ITA Program Standards issued <u>OPSN 2020-006</u>, which detailed the changes to the Automotive Refinishing Technician Program (previously known as Prep Tech (CL1) and Automotive Painter) as a result of the Harmonization Initiative and announced the implementation of a revised Program Profile and Program Outline, effective April 1, 2021. Further to this, on November 25, 2020, ITA announced and posted the <u>Transition Plan</u>, summarized in the graphic below. On April 1, 2022, we will enter Year 2 of the Transition Plan.
