

PROFESSIONAL COOK 2

Occupation Description

“Cook” means a person who performs all phases of kitchen activities including the preparation and presentation of vegetables, soups, sauces, meat, fish and poultry, cold kitchen items; desserts, baking, pastry; basic menu planning/costing as well as knowledge of safety, sanitation and food storage, and who has a knowledge of human and customer relations.

A Professional Cook 2 usually works under some supervision and performs a variety of cooking and food preparation tasks using multiple cooking methods. In addition to using the major techniques and principles used in cooking, baking, and other aspects of food preparation, at this level, a professional cook should have a preliminary understanding of food costing, menu planning, and purchasing processes.

Pathways to Certification

In BC, an individual can become certified as a Professional Cook 2 by completing the Professional Cook 2 program or by challenging the certification. Apprenticeship programs are for individuals who have an employer to sponsor them and challenge programs are for individuals who have extensive experience working in the occupation and wish to challenge the certification.

Recommended and Required Education

The following education is **recommended** for apprentices entering this occupation. These are not prerequisites, but rather a desired level of skill or knowledge that will contribute to success in the industry.

- Grade 10 or equivalent including English 10, Mathematics 10 and Science 10
- Preferred: Grade 12

The following education is **required** prior to enrolment in the technical training for this occupation. It will be verified by the training provider upon enrolment.

- FOODSAFE Level 1 certificate OR equivalent

SkilledTradesBC Registration

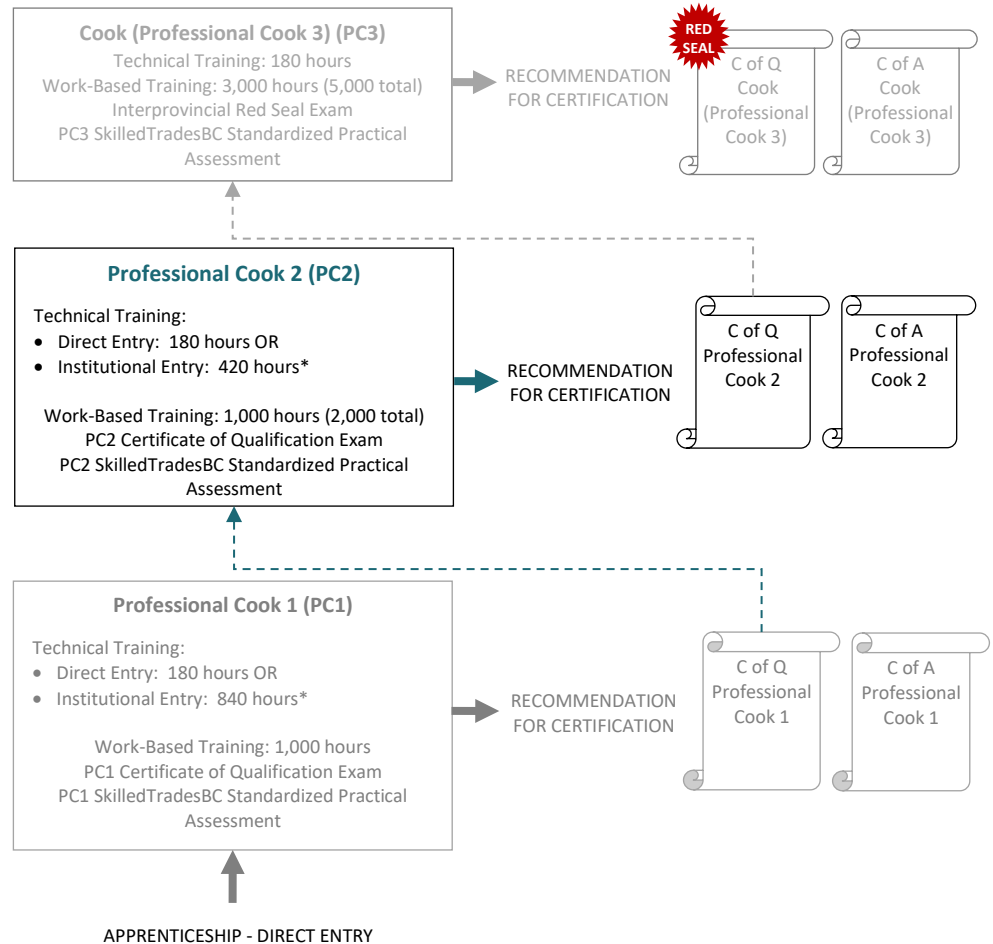
Individuals who wish to begin an apprenticeship in this program must register with SkilledTradesBC along with their sponsors. Application forms for all programs are available from the SkilledTradesBC website. Online registration is also available for most programs through the SkilledTradesBC website.

Those who wish to challenge the Professional Cook 2 certification must complete the Professional Cook 2 Challenge Application and submit it to SkilledTradesBC. Challenge applications are assessed for proof of workplace hours and scope of experience prior to acceptance of the individual into the Challenge pathway.

C of A = Certificate of Apprenticeship*

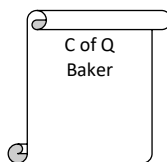

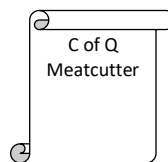

Program Duration	<p>Duration varies depending on how training is delivered, but the program generally takes 1 year to complete.</p> <p>The technical training requirement is typically met through block-release training (full-time, at school) delivered by an SkilledTradesBC-approved training provider. It can also be met through approved alternative training models (e.g., distance education, online, part-time) and/or level challenge where these options are available.</p>

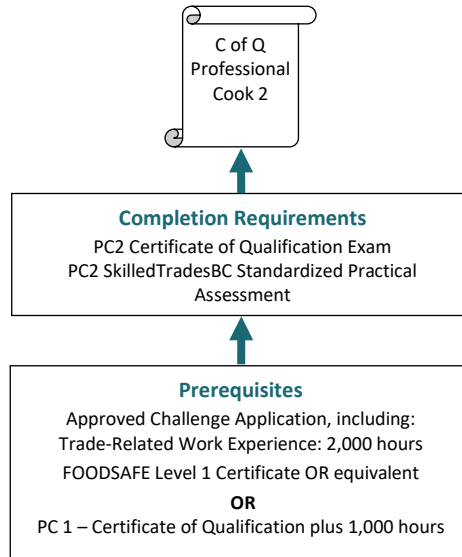

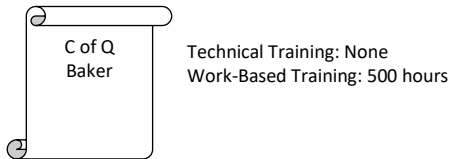
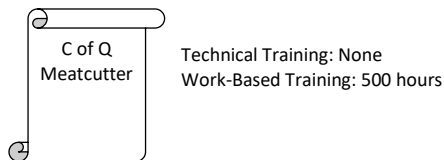
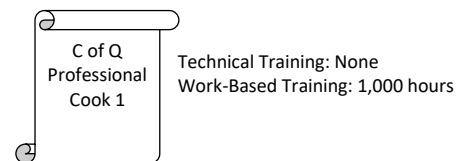
This graphic provides an overview of the Professional Cook 2 challenge pathway.
