## SHIPYARD LABOURER

### **Occupation Description**

Shipyard Labourer provides a variety of services in the shipbuilding and repair industry, including cleaning the yard, materials delivery, setting up for specified work on a vessel, preparing vessel surfaces, performing fire watch and hole watch duties, assisting in docking and undocking vessels and assisting other shipyard workers and trades as required.

#### **Pathways to Certification**

In BC, an individual can become certified as a Shipyard Labourer by challenging the certification. To challenge certification, individuals must meet pre-requisites and demonstrate achievement of core competencies.

There is no training or apprenticeship pathway in BC for this occupation.

However, training in the following subjects will help prepare one for challenging certification. Proof of training must be provided:

- Confined Space
- Lockout Procedures
- Fall Protection
- Fire Watch
- Respirators

### SkilledTradesBC Registration


Those who wish to challenge the Shipyard Labourer certification must complete the Shipyard Labourer Challenge Application and submit it to SkilledTradesBC. Challenge applications are assessed for proof of workplace hours and scope of experience prior to acceptance of the individual into the Challenge pathway.

The Challenge pathway for Shipyard Labourer also involves an SkilledTradesBC-registered Shipyard Labourer Assessor assessing the performance of a Shipyard Labourer challenger, who must meet occupational performance standards set by the industry. The challenger receives certification only after demonstrating evidence of competency in these standards.
