STC Trades Designation Application Form

INTRODUCTION:

The information provided in this Skilled Trades Certification (STC) Trades Designation Application Form is the first phase of review to be completed by SkilledTradesBC and will help identify trades that could benefit from STC designation. The information provided will assist SkilledTradesBC in determining if a nominated trade should move to the next more detailed assessment phase, where various factors are examined, such as undertaking a comprehensive analysis relative to the impact designating a trade as STC may have on BC's labour market. The detailed assessment of various factors will provide further support in identifying trades for recommendation as STC designated trades, which in turn will enable SkilledTradesBC's to develop recommendations for consideration by government.

It is important to note that SkilledTradesBC will use specific criteria to assess all trades nominated as part of this application process. This includes identifying alignment with existing frameworks including if either the trade is: 1) currently regulated in BC, or 2) readily aligns to trades already identified as STC trades (for a list of identified STC trades see <u>https://skilledtradesbc.ca/skilledtradescertification</u>). SkilledTradesBC will also limit the number of trades that proceed to the detailed assessment phase to a maximum of ten (10).

INSTRUCTIONS:

BC businesses, labour organizations, industry associations, and Indigenous communities and organizations who operate in, or have an interest in the skilled trades may nominate a trade for STC designation by completing and submitting this application.

Applications will be a**ccepted between May 11 and June 30**. Applicants will be notified if the trade they have nominated will proceed to the detailed assessment phase.
