

FLOORCOVERING INSTALLER

Occupation Description

Floorcovering installers install, replace and repair a variety of floorcoverings. They work with cushion, carpeting, vinyl, resilient tile, sheet flooring, and seasonal carpet. Floorcovering installers install and repair pre-finished wood, unfinished wood, engineered wood, laminate and artificial turf. Floorcovering installers install and repair floorcoverings in residential and industrial/commercial/institutional (ICI) settings.

Pathways to Certification

In BC, an individual can become certified as a Floorcovering Installer by completing the Floorcovering Installer program or by challenging the certification. Apprenticeship programs are for individuals who have an employer to sponsor them and challenge programs are for individuals who have extensive experience working in the occupation and wish to challenge the certification.

Youth can begin an apprenticeship in high school through the Youth Train in Trades or Youth Work in Trades programs. The Youth Work in Trades program is available for any trade if an employer is willing to sponsor the student. Trades offered through the Youth Train in Trades vary by region; contact your local school district to find out which technical training programs are being offered through the Youth Train in Trades program in your region.

Recommended Education

The following education is **recommended** for apprentices entering this occupation. These are not prerequisites, but rather a desired level of skill or knowledge that will contribute to success in the industry.

- Grade 10 or equivalent including English 10, Mathematics 10 and Science 10
- Preferred: Grade 12





This graphic provides an overview of the Floorcovering Installer challenge pathway.




