



## **MOBILE CRANE OPERATOR**

### **Occupation Description**

“Mobile Crane Operator” means a person who operates a mobile crane to perform lifts and hoists, sets up cranes, takes down cranes, and plans lifts and crane procedures.

### **Pathways to Certification**

In BC, an individual can become certified as a Mobile Crane Operator by completing the Mobile Crane Operator program or by challenging the certification. All crane operators must be registered BC Crane Safety prior to applying for SkilledTradesBC apprenticeship registration. Apprenticeship programs are for individuals who have an employer to sponsor them and challenge programs are for individuals who have extensive experience working in the occupation and wish to challenge the certification.

Youth can begin an apprenticeship in high school through the Youth Train in Trades or Youth Work in Trades programs. The Youth Work in Trades program is available for any trade if an employer is willing to sponsor the student. Trades offered through the Youth Train in Trades vary by region; contact your local school district to find out which technical training programs are being offered through the Youth Train in Trades program in your region.

### **Recommended Education**

The following education is recommended for apprentices entering this occupation. These are not prerequisites, but rather a desired level of skill or knowledge that will contribute to success in the industry.

- Grade 12 or equivalent

### **BC Crane Safety Registration**

BC Crane Safety registration is required for all crane operators in British Columbia. Registration forms are available on the BC Crane Safety website at [www.bccranesafety.ca](http://www.bccranesafety.ca).

### **SkilledTradesBC Registration**

Individuals who wish to begin an apprenticeship in this program must register with SkilledTradesBC along with their sponsor. Application forms for all programs are available from the SkilledTradesBC website. Online registration is also available for most programs through the SkilledTradesBC website.

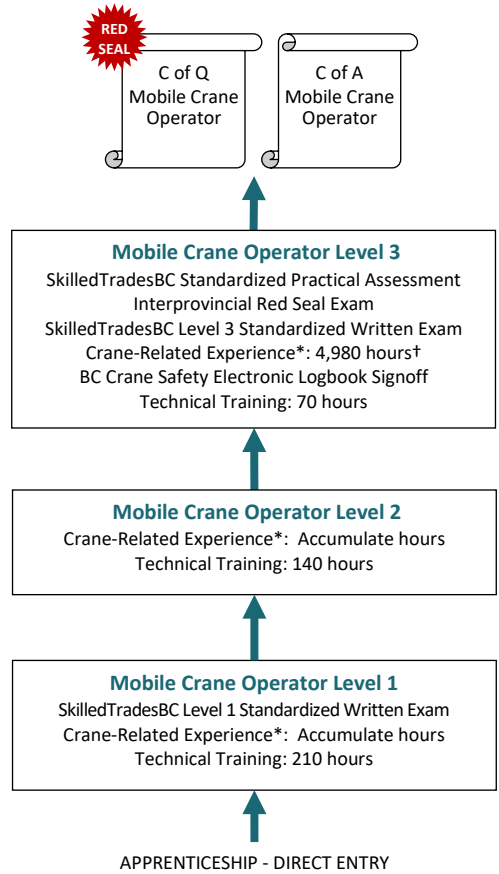
Those who wish to challenge the Mobile Crane Operator certification must complete the Mobile Crane Operator Challenge Application and submit it to SkilledTradesBC. Challenge applications are assessed for proof of workplace hours and scope of experience prior to acceptance of the individual into the challenge pathway.

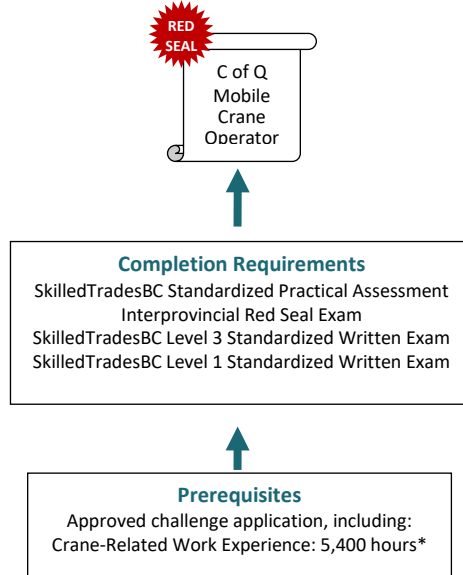
<b>Program Duration</b>	<p>Duration varies depending on how training is delivered and the type and number of workplace hours that are accumulated.</p> <p>The technical training requirement is typically met through block-release training (full-time, at school) delivered by a SkilledTradesBC-approved training provider. It can also be met through approved alternative training models (e.g., distance education, online, part-time) and/or level challenge where these options are available.</p>

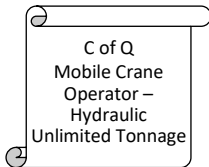

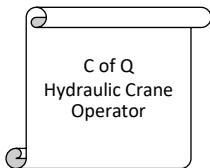

**SkilledTradesBC Registration Prerequisites** An approved Challenge Application, which includes:

- Minimum of 5,400 documented hours of directly-related experience working in the occupation. Must include a minimum of 1,600 hours of mobile crane operating time. Of the 1,600 operating hours, a minimum of 400 hours must be accumulated on one or more of:
  - Mobile lattice friction equipment
  - Mobile lattice hydraulic equipment
  - Mobile hydraulic equipment with capacity greater than 80 tonnes
- Documented evidence of achievement of the competencies listed in the SkilledTradesBC Mobile Crane Operator Challenge Application
