Scheduling Exams:	Exams are to be requested by training providers via the usual SkilledTradesBC procedure. For more information, please see <u>https://www.skilledtradesbc.ca/training-providers</u> . Training providers are required to complete a SkilledTradesBC Exam Request Form 6-8 weeks prior to the scheduled exam date. Training providers are encouraged to use the session ID to identify courses, as this will aid in confirmation of exam type. SkilledTradesBC will provide an invigilator for these exams.
SkilledTradesBC Certificate of Qualification Exams:	 Certificate of Qualification (CofQ) Exams CofQ exams are not blended with in-school technical training marks. A score of 70% or greater is required to pass a CofQ exam. SkilledTradesBC records CofQ exam results in the SkilledTradesBC Portal. Eligibility
	• To write the Parts Technician 1 CofQ exam, apprentices must have achieved a score of 70% in Parts Technician 1 technical training before writing the exam.
